

INVITATION TO BID

Sealed bids will be received by **Treutlen County** at 1830 Martin Luther King Jr. Drive, Soperton, Georgia, 30457, ATTN: **County Administrator/Clerk**, until **Monday, May 2, 2022, at 3:00 p.m. local time**. Late bids will not be considered and will not be returned. **Bid Packages will be available at the address above or may be requested electronically by calling the County Administrator/Clerk, Angie Hooks, at (912) 529-3664, for the project known as: 2022 TIA Road Improvement Project – Ohoopsee Bend PI # 0012451.**

The OWNER of the project is **Treutlen County**. The ENGINEER for the project is Michael Thomas, PE, Wood Environment & Infrastructure Solutions, Inc.

The work to be bid consists of furnishing all materials, labor, tools, equipment, and services required to provide **surface treatment, patching, leveling, and striping on Ohoopsee Bend Road**. **The project scope is shown on the documents as prepared by Wood Environment & Infrastructure Solutions, Inc.** All work is subject to Georgia Department of Transportation standards and specifications.

Each bid shall be accompanied by a Bid Bond in an amount of not less than five percent (5%) of the total bid amount. The Bid Bond may be in the form of a surety issued bond or cashiers check made payable to **Treutlen County**. The Bid Bond shall be forfeited to **Treutlen County** as liquidated damages if the bidder fails to execute the Contract and provide Performance and Payment Bonds within fifteen (15) days after being notified that he has been awarded the Contract.

Surety and insurance companies must have an AM Best rating of A-6 or greater, be listed in the Federal Registry of Companies holding Certificates of Authority and Acceptable Sureties on Federal Bonds, be licensed by the Georgia Insurance Department and the Georgia Secretary of State to do business in the State of Georgia.

Each bid must be submitted in a SEALED ENVELOPE, addressed to the OWNER. Each sealed envelope containing a Bid must be plainly marked on the outside as, **“2022 TIA Road Improvement Project – Ohoopsee Bend PI # 0012451”**. If bid is forwarded by mail, the sealed envelope containing the Bid must be enclosed in a separate mailing envelope to the attention of the OWNER at the address previously given.

Bids may not be withdrawn for sixty (60) days after the time and date set for closing, except as allowed by OCGA. **Treutlen County** reserves the right to reject any and all proposals and to waive any technicalities.
